**2007 TAX INFORMATION**

Dear Investor:

We are pleased to inform you that some State Legislatures have enacted laws providing **potential state or local tax benefits** to shareholders of regulated investment companies that invest, in whole or in part, in **direct obligations of the United States Government and its possessions**. Therefore, a portion of the dividends paid by the Fund in 2007 for certain investors may be "exempt" from state taxes. **Since the qualifications for such exemptions vary by state, we strongly suggest that you consult your tax advisor for details concerning you state's eligibility requirements.**

We believe that you will need the following information in order to determine the applicability of this potential benefit:
